On behalf of my child, I accept and assume any and all risks associated with his/her attendance and participation in American Immersion at McDonogh and its activities. I understand that my child should not attend the program if he/she is not healthy. I understand that my child must abide by program rules and the instructions of the staff. I agree that if my child is dismissed from the program, no part of my fee will be refunded. I understand that no reduction in the fee will be made for late arrival, early departure, vacations, illness or injury. In the event that the holder of this contract is required to turn this matter over to an attorney for collection, I understand that I will be liable to the holder hereof for attorney's fees and costs of suit.

Permission is hereby granted for my child to be transported for any field trips or off-site activities that might be included in his/her specific program. In addition, I hereby grant permission for my child to participate in all swimming and horseback-riding activities.
